**CPF transfer**  
*This option is not eligible for tax relief and matching grants.*

- In general, CPF transfers to your own Special Account or Retirement Account are processed within the same day. However, a longer processing time may be required for certain transfers (e.g. first-time transfers to loved ones, as verification of relationships is required). The processing time for such scenarios may take up to 5 working days upon receipt of application or longer if the volume of application is high.
- CPF transfers are not eligible for [tax relief](#) and [Matched Retirement Savings Scheme](#).
- Before you make CPF transfers to your loved ones, please ensure you have sufficient savings for your own housing and retirement needs.
