CPF "READY FOR LIFE" FESTIVAL EVENT TERMS AND CONDITIONS & AUDIO, PHOTOGRAPHY AND VIDEO RECORDING CONSENT

These event terms and conditions ("Event Terms and Conditions") apply to all participants at the Event. Your registration and/or attendance at the event indicates your agreement to these terms.

(A) EVENT TERMS AND CONDITIONS:

- 1. **CPF "Ready for Life" Festival** (where the festival, activities and the talks shall collectively be referred to as the "**Event**") is organised by the Central Provident Fund Board ("**CPFB**"). The Event will be held on 25 October 2025. Registration is required for access to the Event.
- 2. These Event Terms and Conditions shall be read together with any other rules and/or terms and conditions applicable to the Event (including the **CPF "Ready for Life" Festival Website's** Terms of Use [https://www.cpf.gov.sg/member/terms-of-use]) and shall apply to all segments of the Event. By registering for and/or attending this Event (including the talks), you agree to be bound by these Event Terms and Conditions and all rules relating thereto. If you do not agree to these Event Terms and Conditions, you should not register for or attend the Event.
- 3. Registration details of each participant must be registered with us either before the start of, or anytime onsite during the Event. We reserve the right to exclude from the Event any individual whose details do not appear on our register of participants. All registrations for the Event are subject to availability and to acceptance by CPFB at its absolute discretion. Participants below 18 years old must obtain the consent of his/her parent or legal guardian before participating in the Event.
- 4. You hereby expressly agree and acknowledge that CPFB shall be under no liability whatsoever to you or your personal representatives, in respect of any loss or damage (including loss or damage to life or property) suffered by you arising from or pursuant to the Event or sustained by you during or in connection with participation in the Event.
- 5. Your personal data will be collected, used, disclosed and/or processed by CPFB and its third party vendors, representatives or business partners or agents (where applicable) for the following purposes: (a) for CPFB or its designated representatives, vendors or business partners or agents to provide services to you (including the Event) or parties designated by you and matters ancillary thereto or for any other operational purposes; (b) for verification and record of your personal particulars including comparing it with information from other sources and using the information to communicate with you; (c) for research and analysis, including surveys and polls; (d) to send you email reminders to attend the Event and post-Event information; and (e) any related purposes.
- 6. You shall not speak to the press or other media nor give any interviews or comments relating to the Event, either before, during or after the Event, unless such interviews are conducted in the presence of CPFB staff or with the consent of CPFB.
- 7. CPFB's decision on all matters in relation to the Event is final. No enquiries, appeals, verbal or written, shall be entertained. You shall accept and abide by any and all decisions made by CPFB concerning, without limitation, these Event Terms and Conditions, the rules of participation in the Event, and any other matters relating to the Event.
- 8. CPFB reserves the right to amend or vary any of these Event Terms and Conditions, and the Event, the talks and the Event dates, timings, topics and contents without prior notice to you or any other participant. CPFB further reserves the right, without any liability to you or any other participant(s), to disqualify you or any other participant(s) from attending and/or participating in the Event at any time at its discretion.
- 9. You shall indemnify and keep CPFB and its related/affiliated companies, officers, agents and employees (the "Indemnified Parties") fully indemnified against any and all loss, damage, claims and costs (including legal costs on a full indemnity basis) suffered and/or incurred by any of the Indemnified Parties as a result of your breach of any of these Event Terms and Conditions.

(B) CONSENT TO AUDIO, PHOTOGRAPHY AND VIDEO RECORDING AND USE OF MATERIALS

10. CPFB owns all rights of any audio, photograph or video captured during CPFB's talks or at any part of the Event, as well as all the materials and items produced by you during any of the activities at the Event.

- 11. - 15. For the avoidance of doubt, you acknowledge and agree that the copyright and all intellectual property rights in and to the format of the Event (including the talks) vests in CPFB. You understand and agree that all recordings from the Event or materials produced as part of the Event are the exclusive rights of CPFB and you do not ask for or expect compensation for the use of recordings or photographs in which you appear or speak.
- 16. You release CPFB, its officers and employees, its vendors and each and all persons involved from any liability connected with the taking, recording, digitising, or publication of interviews, photographs, computer images, video/ sound recordings or any other materials.
- 17. You agree that CPFB and its assigns have the right and permission to use such recordings, materials and photographs (including in original form) and notwithstanding should they include your name, likeness, voice, biographical details, testimonial or photograph, for marketing, advertising or any other purpose in any media or format, online and/or offline, now or hereafter without further compensation, permission or notification to you.
