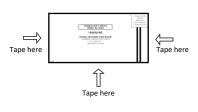
## How to use the Business Reply Envelope?

## Information on Application for GIRO

- The CPF member will receive a notification on the status and effective date of the GIRO arrangement upon the bank's approval of the
  application.
- Please ensure you have enough balance in your bank account before the deduction date. If you have set a payment limit on your GIRO deduction with your bank, ensure that the limit is sufficient to pay for the MediSave Contributions. Some banks may charge an administrative fee for each unsuccessful deduction.
- If the CPF member has an existing GIRO arrangement with CPF Board and wishes to change the bank account, a new GIRO application form will need to be completed. The deduction for MediSave Contributions from the existing bank account will continue until the new GIRO application is approved.
- If the CPF member is an undischarged bankrupt, they must first obtain approval from the Official Assignee to make MediSave Contributions.
- GIRO deductions for any outstanding MediSave Contributions will be made on the 25<sup>th</sup> of the month (or the next working day if the 25<sup>th</sup> falls on a Saturday, Sunday or public holiday).
