- 2. I declare that the information and Bank Account details given in this application are correct and complete to the best of my knowledge.
- 3. I understand that payment will be made to me according to the Bank Account details provided in this form. I agree to pay all bank charges levied in connection with this transaction, including any charges or fees levied for the rejection of any payment should the details above be inaccurate.
- 4. I hereby declare that I shall at all times hereafter indemnify the Central Provident Fund Board and hold the Central Provident Fund Board harmless from and against all actions, proceedings, claims, liabilities, penalties, awards, damages, costs (including without limitation, legal costs of the Central Provident Fund Board on a solicitor and own client basis), expenses and any loss whatsoever, however arising, directly or indirectly, which the Central Provident Fund Board may be liable to incur or suffer as a result of releasing such CPF monies to me through my aforesaid Bank Account.
- 5. I irrevocably authorise CPF Board to share my NRIC number and/or other identification number and Bank Account information with the Government and other public sector agencies (including statutory boards) and authorised agents of the Government (collectively, the "the Government and Paying Agencies"), for the purpose of crediting cash payments from the Government and Paying Agencies to me using the Bank Account.
- 6. I also authorise CPF Board to credit any payment due to me:
  - a) under the CPF Act and its subsidiary legislation; and
  - b) from the Government in respect of which CPF Board is the administrator, agent or trustee, to the Bank Account.
- 7. I irrevocably consent to and authorise the Bank, including any officer thereof, to disclose to CPF Board and the Government and Paying Agencies any information whatsoever relating to me and to the Bank Account as is necessary for the purpose of verifying and making payment to my Bank Account. This consent shall survive the termination of the Bank Account with the Bank and may be relied on and enforced as fully and effectively by the Bank as if it was addressed to the Bank.
- 8. I understand that CPF Board, the Government and the Paying Agencies have the absolute discretion to decide whether to verify information relating to me or my Bank Account. I will not hold CPF Board, the Government and the Paying Agencies responsible if they decide not to perform such verification.

#### **Important Notes**

- 1. Payment will be credited into the Bank Account as stated in Section 2 via:
  - a. Interbank GIRO (IBG) for a Singapore bank account.
  - b. Telegraphic Transfer for an overseas bank account. You will need to ensure that the bank accepts payment in Singapore dollars.
- 2. Please obtain your bank's certification of your Bank Account information at Section 2 or mail us your original bank statement for verification. Online bank statements are not acceptable. Bank certification is not required for a Singapore POSB, DBS, OCBC or UOB bank account maintained under your Singapore NRIC.
- 3. If the bank account information is not provided or is incomplete, we will issue you a cheque in Singapore Dollars. (Note: For overseas bank clearance of the cheque, you will need to bear all bank charges.)
- 4. Upon approval of your application, your CPF savings or part thereof will be forwarded to Inland Revenue Authority of Singapore to settle your liabilities (if any).
